





No structural modifications will be required for the new windows. After the windows are replaced, I will be looking to repair some broken shingles and paint the exterior (intent will be to pick a paint that will keep the light gray "original" look. Regardless of color, I am assuming that a Certificate of Appropriateness will NOT be required. Can you confirm this? Thank you.
